**Payment:** A non-refundable \$350 enrollment deposit is due upon acceptance to the Pre-College Program or Summer College for High School Students to reserve a space in the Pre-College program AND to secure enrollment in your preferred course. ### WITHDRAWAL/REFUND POLICY

# **Six-Week Credit Courses**

**Withdrawal:** A student may withdraw or change their credit course schedule only with permission and approval from the Director of Summer Programs. Students may withdraw from a credit course and receive a full tuition refund on or before May 21, 2024 (1st session) and July 5, 2024 (2nd session). The enrollment deposit is non-refundable. After the drop/ add period (May 21 for session 1 and July 5 for session 2) tuition refunds are prorated according to the following schedule.

## **Two-Week Noncredit Courses**

**Noncredit Program Cancellation:** If a student wishes to cancel their program attendance and enrollment, they must notify the Pre-College Program in writing by email:

precollege@emory.edu. Students who cancel their attendance two weeks before the session start are eligible for a *tuition refund, NOT the \$350 non-refundable enrollment deposit and \$70 non-refundable application fee*. Program fee charges are also not refundable.

All students registered for a noncredit course(s) must attend on or before the second day of class (June 18, July 2, or July 16). Otherwise, enrollment will be canceled.

Withdrawal: Students may not change noncredit courses or attend another class once the session begins. A student may withdraw from one or more courses only with permission and approval from the Director for Summer Programs. Students who withdraw from the program and/or a noncredit course on or before the second day of class (June 18, July 2, or July 16) will receive a 50% tuition refund minus the \$350 non-refundable enrollment deposit. Application fees, enrollment deposit, books, and program fees are non-refundable.

If you make your deposit via credit card – **either international or domestic** – and a refund request is approved due to a canceled course, please first attempt to dispute the deposit/charge with your credit card company. If your dispute is denied, a paper check can be mailed to the student's permanent address on file (US addresses only.)

A student who withdraws from the course/program may not continue to participate in program activities or utilize university facilities.
